JEOL Ltd. (the "Company") hereby announces that it has resolved, at a meeting of the Board of Directors held on May 28, 2025, to construct a new building at the Akishima Main Office Plant as follows.

It also plans to construct a new building at the Tendo Plant (JEOL Yamagata Co., Ltd.) in Yamagata Prefecture.

### 1. Purpose

The new buildings will be constructed as part of the growth strategy under the new medium-term management plan "Evolving Growth 2.0 - A New Horizon -" launched this fiscal year, and the Company will build a strong business foundation for sustainable growth. Based on the concept of optimizing the Company's production bases, it will build environment-friendly plants that actively incorporate energy-saving technologies while striving to further improve productivity by incorporating the smart factory concept, for the purpose of conducting R&D and production of high-end scientific and metrology instruments, which will is expected to serve as a key pillar of future growth, at the Akishima Main Office Plant and the aim of cost reduction and shortened work periods for scientific and metrology instruments at the Tendo Plant.
